To provide a clearer picture of the impact of inclusive education based on Islamic values on religious moderation, here are some hypothetical data:

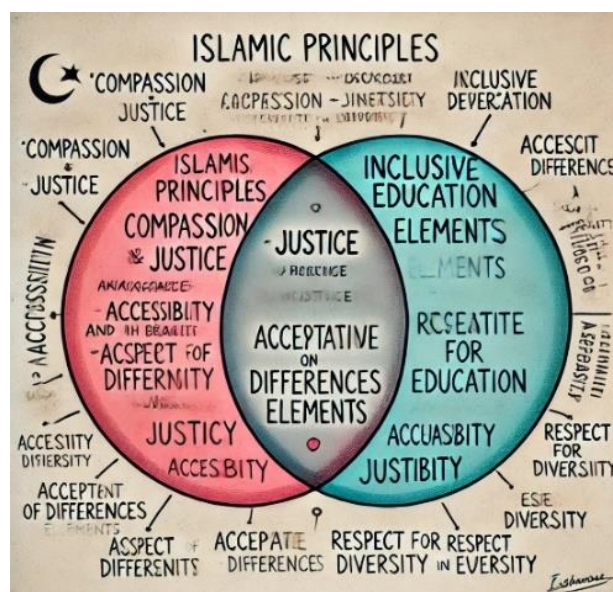

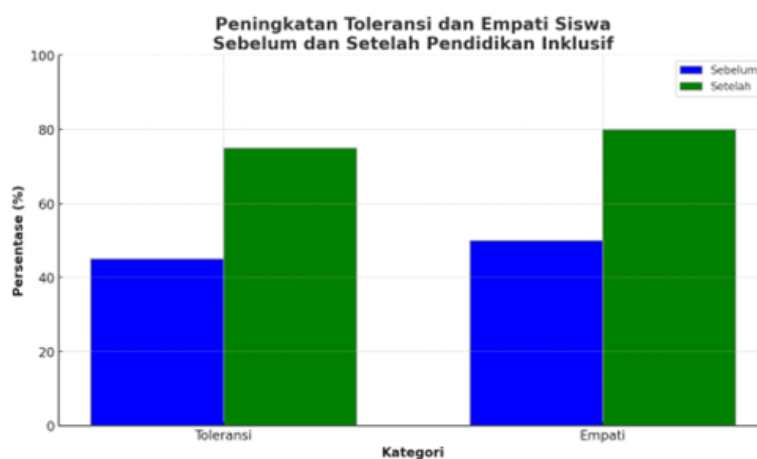
